

# The Italian mountains and forests


Rich but at the same time fragile territories:

-Depopulation;

-Abandonment;

-Lack of essential services;

-Pulverization and land fragmentation.



 Pulverization: creation of extremely small land particles, such that optimal and economically convenient management is not possible.

Fragmentation: the relocation of land belonging to a single owner in distant or non-contiguous locations, **negatively impacting management methods**.



# Italian legislation against forest land fragmentation

D.Lgs. 3 aprile 2018, n. 34 - Testo unico in materia di foreste e filiere forestali Consolidated Law on Forests and Forestry Supply Chains (TUFF)

Art.2 c.1 promote and protect the forestry economy, the mountain economy and their respective production chains as well as the development of agro-forestry-pastoral activities **through** the protection and rational use of the soil and **the productive recovery of fragmented land properties and abandoned lands, supporting the development of forms of associated management of public and private forest properties**;



# Italian legislation against forest land fragmentation

D.Lgs. 3 aprile 2018, n. 34 - Testo unico in materia di foreste e filiere forestali Consolidated Law on Forests and Forestry Supply Chains (TUFF)

### Art.10 c.5

"In order to ensure the protection and active management of agricultural, forestry, and pastoral resources, the recovery of abandoned lands, and the re-establishment of economically sustainable production units capable of promoting employment, as well as the creation and consolidation of new entrepreneurial activities, the Regions promote land associations among the owners of public or private lands...omissis...as well as the establishment and participation in forestry consortia, cooperatives operating mainly in the forestry sector, or other forms of association between landowners and those **responsible for managing land assets**, enhancing the joint management of small properties, state-owned lands, collective properties, and the civic uses of local communities."



### **Consolidated Law's (TUFF) Implementing Decrees**

- 1. Definition of national criteria for registration in regional registers of forestry companies (Ministerial Decree No. 4470 of 29 April 2020).
- 2. Definition of national minimum criteria for professional training of forestry operators (M.D. No. 4472 of 29 April 2020).
- 3. Guidelines for the definition of criteria for exemption from compensatory measures for forest transformation (M.D. No. 9219119 of 07/10/2020).
- 4. Provisions for the definition of the minimum national standards for the recognition of the state of abandonment of agro-pastoral activities (Interministerial Decree No. 0365201 of 12 August 2021).
- 5. Provisions for the establishment of minimum national standards for the preparation of territorial forest plans, and forest management plans, or equivalent instruments (I.D. No. 563765 of 28 October 2021).
- 6. *Guidelines for the identification of areas that can be defined as old-growth forests* (I.D. No. 608943 of 18 November 2021).
- 7. *Provisions for the definition of minimum national criteria for works related to forest and watershed management* (Ministerial Decree No. 563734 of 28 October 2021).

### 8. National Forest Strategy (I.D. No. 677064 of 24 December 2021).

- 9. Technical standards for the elaboration of technical-scientific cartography for the drafting of forest planning tools (Departmental Decree No. 64807 of 9 February 2023).
- 10. Establishment of the National Network of old-growth forests (M.D. No. 193945 of 05 April 2023).



# National Forest Strategy (NFS)

**The NFS (2022)** – promoted by the Ministry of Agriculture in collaboration with the Ministries of Environment, Culture, and Economy, as well as the State-Regions Conference – represents an essential tool for outlining national forest policies within the framework of European policies and international agreements, defining national guidelines for the protection, enhancement, and active management of the national forest heritage and for the development of the forest sector.

The document is the result of a significant and extensive **process of sharing, both through a multidisciplinary drafting table and through a public consultation**, followed by substantial **work to harmonize themes and language**, in close connection with the other implementing decrees of the TUFF The SFN is valid for 20 years and is subject to review and update every 5 years.

It's already funded for 10 years:

- EUR 30 million for the first 2 years (2022-23)
- EUR 40 million for each subsequent year (until 2032).



# National Forest Strategy promote associations and land consolidation among public and private landowners

The promotion towards forms of associated management is explicitly mentioned in the following operational actions:

**Operational Action A.2** - Ecosystem services and payments - Sub-Action A.2.1 - Recognize and remunerate the public, environmental and social services provided by forests and maintained and increased by SFM.

**Operational Action B.1** - Sustainable Forest Management - Sub-Action B.1.1 - Improve and increase SFM in existing forests.



## Fund for the implementation of the National Forest Strategy

Distribution of resources to Regional Administrations (2022-2023)

Each Region or Autonomous Province independently allocates these financial resources, assigning them in varying amounts to the implementation of all or only some of the actions provided for by the SNF, taking into account local specificities.

### NFI, Instrumental Action 1.4: National Forest Information System (SINFor) and new National Forest Map



Based on the provisions of the "Framework Law on Forests and Forestry supply chain," (TUFF), Italy is currently developing the National Forest Information System (SINFor), which is an innovative strategic tool to support the implementation of the National Forest Strategy.

➤ The SINFor System is made up of two interconnected survey environments, the National Forest Map and the Information System on forest sector, which provide up-to-date and reliable knowledge through the collection and consultation of timely and specific forestry data and information.

SINFor provides a unified point of access to data and information from the wide range of knowledge available on forestry in Italy.



# CAP Strategic Plan 2023-2027

The forestry interventions adopted by Italy in the CAP Strategic Plan 2023-27 (PSN) are aimed at pursuing the objectives set out in the EU Forestry Strategy (COM/2021/572 final) and in the EU Biodiversity Strategy (COM(2020) 380 final), transposed in the Framework Law on Forests and Forestry supply chain (TUFF), in the National Forestry Strategy (SFN), and in the Forestry Programmes of the Regions and Autonomous Provinces.

For the forestry sector, the components of the Regional Strategic Plan (RSP) included must follow and enable the implementation of the TUFF and the NFS.

Compared to the previous 2014-2022 programming period, there has been a reduction in the resources committed at the national level by the regions for forestry interventions co-financed with rural development (about 15% less), despite the strategic role played by forests in climate, environmental and development challenges.

➢ In total, the resources available for all forestry interventions do not exceed 4% of the available NSP resources. Investments in the forestry sector alone are approximately 424 million euros.

- n. 27 beneficiary associations (22 from the Italian Southern Regions)
  have received funds
- 82.682 hectares involved
- 4.688.904,72 euro (96% of availability) resources allocated
- n. 23 new formed associations
- n. 4 associations already established



# Conclusion

- Private forest ownership is a fundamental element of the landscape and must be supported in order to fulfill its role in sustainable forest management.
- The National Forest Strategy will provide resources over the next 10 years to implement land consolidation measures and promote associations among forest owners.
- The experience of the POA project, although small and with limited resources, was highly positive and paved the way for the funding of further projects in this sector.
